<p><b>Qualification Description</b></p> <p>This qualification reflects the role of individuals <u>working in or providing services related to the greyhound racing industry.</u>  <u>It allows for three specialisations, including</u></p> <ul style="list-style-type: none"> <li>• <u>greyhound trainer - licensed to operate a business that trains greyhounds under racing industry regulated licensing criteria for the purpose of competing in industry-regulated events</u></li> <li>• <u>greyhound health assistant – providing independent greyhound health services for industry participants</u></li> <li>• <u>greyhound transition to pet – providing services to assess, educate and transition greyhounds bred for racing to pets in new homes. -in the greyhound racing code.</u></li> </ul> <p>It covers the care, maintenance and performance of greyhounds and the tasks and duties associated with running a racing establishment, including managing staff, finances and equipment. Trainers are responsible for planning and organising their own work, leading others and carrying out often complex and non-routine tasks.</p> <p>Licensing, legislative, regulatory or certification requirements may apply to this qualification. Refer to your state or territory Controlling Body or Principal Racing Authority for current licence or registration requirements.</p>	
<p><b>Entry Requirements</b></p> <p>To undertake this qualification the individual must have:</p> <ul style="list-style-type: none"> <li>• skills and knowledge commensurate with <i>RGR20117 Certificate II in Racing (Greyhound)</i> demonstrating industry-relevant experience in the care, welfare and management of greyhounds.</li> </ul>

For the award of the *Certificate IV in Greyhound Racing Industry (Transition to Pet)* choose:

- all 5 electives from Group C
