Application	<p>This unit of competency describes the skills and knowledge required to perform mobile surveillance.</p> <p>The unit applies to individuals who are required to carry out surveillance on foot, vehicle and public transport, and apply aerial and electronic surveillance, surveillance in remote areas and other alternative surveillance techniques.</p> <p>All work must be carried out to comply with workplace procedures, according to state/territory health and safety, biosecurity and environmental regulations, legislation and standards that apply to the workplace. Licences will be required if operating a vehicle.</p> <p>Regulatory requirements apply to this unit. Users are required to check with the relevant jurisdiction for current requirements.</p>

Maintain mobile surveillance	1.1 Confirm the identity of the subject for surveillance 1.2 Select and prepare officers for the surveillance team and equipment for the environment in which surveillance will be undertaken 1.3 Maintain surveillance of the subject at all times according to operational requirements and relevant jurisdictional policies and procedures and legislation 1.4 Monitor the subject's movements under all conditions through appropriate observation positioning including covering exit and entry points to the area 1.5 Use communication techniques and equipment according to operational requirements 1.6 Complete running sheets in the prescribed format and include accurate descriptions of subjects, vehicles and location 1.7 Keep equipment and evidence secure during the surveillance operation

Maintain covert nature of surveillance operation	2.1 Maintain the covert nature of the surveillance using techniques appropriate for foot and/or vehicle surveillance according to relevant jurisdictional policies and procedures and legislation 2.2 Ensure surveillance positions are not compromised by the movement of officers during the period of observation 2.3 Recover officers performing foot surveillance without compromise 2.4 Conceal or disguise equipment and documentation during surveillance operation

Respond to changes in surveillance operation	3.1 Apply appropriate search techniques following loss of subject 3.2 Recognise the need for counter-surveillance and/or anti-surveillance techniques and select and apply appropriate actions according to relevant jurisdictional policies and procedures and legislation 3.3 Manage timing and position of changeovers to control surveillance of subject, security of officers and to ensure the covert nature of the operation 3.4 Identify and request the need for alternative surveillance techniques 3.5 Use appropriate static surveillance positions to support mobile surveillance operation as determined by the surveillance plan or in response to changing requirements of the current operation

Performance Evidence	
<p>An individual demonstrating competency must satisfy all the elements and performance criteria of this unit. There must be evidence that the individual has performed mobile surveillance for at least one surveillance operation including:</p> <ul style="list-style-type: none"> • selecting and preparing team of officers and equipment for surveillance • identifying, observing, maintaining and monitoring surveillance of subject • maintaining security of equipment and evidence • using and completing a running sheet • using appropriate communication techniques and technology • applying appropriate foot surveillance skills for the covert nature of the surveillance • applying appropriate driving surveillance skills for the covert nature of the surveillance • responding to contingencies with the appropriate actions • working effectively with a team of officers in carrying out mobile surveillance.
