They complete routine activities and work in a range of known contexts within horse breeding environments.</p> <p>No occupational licensing or certification requirements apply to this unit at the time of publication.</p> <p>Work health and safety and animal welfare legislation relevant to interacting with horses applies to workers in this industry. Requirements vary between industry sectors and state/territory jurisdictions. Users are advised to check with the relevant authority for specific requirements.</p>

Prepare to transport horses	1.1 Check directions for transport and identify horses to be loaded 1.2 Determine transport requirements, including vehicle configuration and engage a suitable carrier 1.3 Select and correctly fit personal protective equipment for safe loading and/or unloading of horses 1.4 Select gear and equipment for loading horse and check gear for safety 1.5 Assess and control risks associated with transporting horses at all stages 1.6 Obtain permits or complete documentation according to workplace or regulatory requirements
2. Load horses	2.1 Identify and control existing and potential hazards and safety risks to handler and horse when loading and unloading horses 2.2 Assess horses to confirm suitable condition for transporting 2.3 Fit gear correctly and prepare horses for loading to transport according to workplace procedures 2.4 Load and position horses according to transport configuration and secure using safe horse handling techniques and restraints
3. Monitor, transport and unload horses	3.1 Ensure horses are transported with minimal stress and discomfort 3.2 Check horses regularly throughout the journey and unload for feeding and watering according to animal welfare standards and practices 3.3 Unload horses using safe and humane handling techniques 3.4 Monitor horse condition and welfare after transport and provide appropriate feed and water

TITLE	Assessment requirements for ACMHBR301 Transport horses
Performance Evidence	
<p>An individual demonstrating competency in this unit must satisfy all of the elements and performance criteria of this unit.</p> <p>There must be evidence that the individual has:</p> <ul style="list-style-type: none"> • transported at least three different horses to two different locations, including for each occasion: <ul style="list-style-type: none"> • prepared horses and organised transport • loaded and unloaded horses using safe handling techniques • monitored welfare of horses at all stages. 	

Knowledge Evidence	
<p>An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:</p> <ul style="list-style-type: none"> • requirement for preparing horse transport vehicles for loading different classes of horses: <ul style="list-style-type: none"> • pregnant mares • mares and foals • weanlings • yearlings • colts • stallions • suitability of transport for different horses, including: <ul style="list-style-type: none"> • load capacity • design, configuration and layout • monitoring technology • strategies and techniques for preparing different classes of horses for transport • assessing and controlling risks associated with transporting horses • animal welfare requirements, including: <ul style="list-style-type: none"> • overview of animal welfare frameworks • regulations for transporting livestock, including horses • animal welfare considerations relevant to transporting horses, including: <ul style="list-style-type: none"> • distance to be travelled, rest breaks • air quality and flow of air • restraints • weather (temperature and humidity) • specific requirements relating to type or breed of horse • workplace policies for use of vehicles and equipment • safe methods of handling and loading horses • safe use of restraints • industry and legislative requirements for the transporting of horses, including biosecurity requirements • relevant documentation requirements and procedures. 	

Assessment Conditions	
<p>Assessment of skills must take place under the following conditions:</p> <ul style="list-style-type: none"> • physical conditions: <ul style="list-style-type: none"> • a workplace or an environment that accurately represents workplace conditions • resources, equipment and materials: <ul style="list-style-type: none"> • various horses for transport, including different classes of horses assessed as suitable for the experience and skill of the individual • carrier and/or vehicle (or float) to transport horses • appropriate tack and equipment for loading and transporting horses • personal protective equipment correctly fitted and applicable to activity for the individual • specifications <ul style="list-style-type: none"> • work instructions and workplace documentation.
