Performance Evidence

An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit.

There must be evidence that the individual has:

- educated two horses to carry loads over different terrains whilst being led on foot and from another horse
- educated one horse to respond obediently to an overnight camp routine and yard restraints
- demonstrated safe horse handling and riding skills and appropriate education techniques to ensure their own and other's safety and the welfare of the horse at all times.

Knowledge Evidence

An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:

- safe work practices when interacting with horses, including:
 - assessing and controlling risks
 - safe horse handling techniques
 - · safe zones around horses
 - · duty of care for others
 - use of appropriate personal protective equipment (PPE) for activity
- equine behaviour, including:
 - body language and vocalisations
 - temperament and characteristics of different breeds and classes of horses
 - affective states, including fear, anxiety, hunger, fatigue
- behaviours and conditions, typically linked to strong flight or fight response, including:
 - · fearful, nervous, timid, anxious behaviour
 - aggressive responses to people and/or other equines
 - overt signs of stress or injury
 - · fears of specific stimuli
- high risk behaviours to people including, biting, kicking, panicking, bucking and rearing
- key features of current research on equine cognition, intelligence, ethology and learning abilities relevant to training horses
- · techniques to shape or modify horse behaviour
- horse characteristics suited to carrying loads and walking trails, including:
 - sound feet and legs, sturdy conformation, physical strength, shorter stature
 - mature age fully developed bone structures
 - calm, patient temperament
 - · obedient in hand and under saddle not easily spooked by noise and unfamiliar objects
- facilities and environments for educating pack horses, including:
 - · controlled areas arenas, fenced tracks
 - uncontrolled areas range of terrains and obstacles
- tack and equipment, including:
 - bridle, halter
 - breeching, breastplate, hobbles, cruppers
 - · pack saddle and saddle pads
 - paniers and pack bags
 - temporary yarding
 - hi-lines, tree guards for tying up horses
- purpose of tack and equipment, how to fit correctly and how to check condition and working order
- range of job roles, environments and terrains where pack horses are used
- camp or overnight routines and environments for pack horses
- · criteria for matching the pack horse with lead horse, including temperament, size, speed and stamina
- features to include in an education plan, including objectives, stages and timeframes
- · range of purposes for pack horses, including recreation, tourism and farm, agricultural work.

Assessment Conditions

Assessment of skills must take place under the following conditions:

- physical conditions:
 - a workplace or an environment that accurately represents workplace conditions including controlled and open/uncontrolled areas
- · resources, equipment and materials:
 - variety of horses appropriately educated in basic handling skills and assessed as suitable for handling by the individual
 - personal protective equipment (PPE) correctly fitted and applicable to activity for the individual
 - appropriate tack and gear required for education program.

Training and assessment strategies must show evidence of the use of guidance provided in the *Companion Volume: User Guide: Safety in Equine Training.*

Assessors of this unit must satisfy the requirements for assessors in applicable vocational education and training legislation, frameworks and/or standards.
