<b>Application</b>	<p>This unit of competency describes the skills and knowledge required to prepare and operate watering equipment and complete watering operations for mushroom crops.</p> <p>The unit applies to individuals who water mushroom crops under general supervision with limited autonomy or accountability.</p> <p>No licensing, legislative or certification requirements apply to this unit at the time of publication.</p>

2. Operate watering equipment	2.1 Follow site quarantine protocols and farm and personal hygiene requirements 2.2 Check and adjust water pressure to ensure correct spray or droplet pattern is achieved 2.3 Provide and distribute evenly water in the correct quantity and pressure 2.4 Report and fix faults or variations 2.5 Identify workplace health and safety hazards and report to supervisor 2.6 Identify environmental and biosecurity implications associated with work and minimise impact

Finalise watering operations	3.1 Read water meter for area and record amount of water used 3.2 Disconnect watering equipment and return to storage area 3.3 Identify and report unserviceable watering equipment according to workplace procedures 3.4 Report work outcomes and seek feedback on performance

<b>TITLE</b>	<b>Assessment requirements for AHCPHT208 Water mushroom crops</b>
<b>Performance Evidence</b>	
<p>An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit. There must be evidence that the individual has watered mushroom crops on at least three occasions and has:</p> <ul style="list-style-type: none"> <li>• assembled, connected and maintained watering equipment</li> <li>• minimised environmental impacts associated with watering mushroom crops</li> <li>• followed industry and workplace biosecurity procedures</li> <li>• applied workplace health and safety requirements</li> <li>• delivered water to the mushroom crop at required rate and pressure</li> <li>• estimated flow rate of water by the range of watering equipment in use</li> <li>• measured correct doses of additives for water</li> <li>• recorded water use</li> <li>• reported unserviceable tools and equipment, and work outcomes to supervisor and seek feedback.</li> </ul>	
<b>Knowledge Evidence</b>	
<p>An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:</p> <ul style="list-style-type: none"> <li>• principles and practices for watering mushroom crops, including: <ul style="list-style-type: none"> <li>• effect on mushrooms of under-watering, overwatering, insufficient evaporation, late watering and moisture imbalance</li> <li>• effects of water on casing structure, mycelium, yields and quality</li> <li>• factors affecting effective operation of watering tree or other equipment used</li> <li>• how panning occurs</li> <li>• light, medium and heavy water and when each type is used</li> <li>• safe and effective use of fungicides and other water additives</li> </ul> </li> <li>• workplace requirements applicable to health and safety in the workplace for watering mushroom crops</li> <li>• environmental impacts associated with watering mushroom crops</li> <li>• industry and workplace biosecurity procedures.</li> </ul>	
<b>Assessment Conditions</b>	
<p>Assessment of skills must take place under the following conditions:</p> <ul style="list-style-type: none"> <li>• physical conditions: <ul style="list-style-type: none"> <li>• a workplace setting or an environment that accurately represents workplace conditions</li> </ul> </li> <li>• resources, equipment and materials: <ul style="list-style-type: none"> <li>• mushroom watering equipment</li> <li>• water additives</li> </ul> </li> <li>• specifications: <ul style="list-style-type: none"> <li>• workplace requirements applicable to health and safety in the workplace for watering mushroom crops</li> <li>• industry and workplace biosecurity procedures applicable to watering mushroom crops</li> </ul> </li> <li>• relationships: <ul style="list-style-type: none"> <li>• supervisor</li> </ul> </li> <li>• timeframes: <ul style="list-style-type: none"> <li>• according to job requirements.</li> </ul> </li> </ul> <p>Assessors of this unit must satisfy the requirements for assessors in applicable vocational education and training legislation, frameworks and/or standards.</p>
