# **Qualification Description**

- Assistant Account Manager
- Assistant Wholesale Buyer
- Assistant Import Agent
- Assistant Purchasing Manager

No licensing, legislative or certification requirements apply to this qualification at the time of publication.

# **Entry Requirements**

There are no entry requirements for this qualification.

#### **Packaging Rules**

To achieve this qualification, competency must be demonstrated in:

- 14 units of competency:
  - 14 elective units.

Elective units must ensure the integrity of the qualification's Australian Qualification Framework (AQF) alignment and contribute to a valid, industry-supported vocational outcome. The electives are to be chosen as follows:

- all units from Group A
- at least 12 units from the remaining electives listed below
- up to 2 units from any currently endorsed Training Package or accredited course.

Any combination of electives that meets the packaging rules can be selected for the award of the Certificate IV in Timber Building Products Supply.

Where appropriate, electives may be packaged to provide a qualification with a specialisation area as follows:

- · all units must be selected from Group A
- 5 units must be selected from Group B for the award of the Certificate IV in Timber Building Products Supply (Purchasing) or
- 5 must be selected from Group C for the award of the Certificate IV in Timber Building Products Supply (Account Management)
- 7 units must be selected from the remaining electives. Up to 2 of these electives may be selected from any currently endorsed Training Package or accredited course.
