# TITLE Assessment requirements for ACMGRM302 Perform grooms on cross breed dogs

#### **Performance Evidence**

An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit.

There must be evidence (direct observation or video evidence) that the individual has:

- independently performed at least five full grooms for cross breed dogs with different coat types including one of each of the following coat types:
  - long/drop coat
  - double/heavy coat
  - combination/silky coat
  - fluffy/curly coat
  - short/smooth coat
  - wiry coat
- at least one dog must have special handling requirements select one from:
  - nervous dog
  - senior dog or dog with restricted movement
  - puppy or inexperienced dog.

In doing the above, the individual must have:

- assessed the dog's conformation, health and coat condition and special handling requirements
- used grooming techniques to establish, maintain or restore coat for cross breed dogs
- identified dog behavioural characteristics and special requirements in consultation with at least three different clients
- handled and secured dogs in a safe and humane manner
- selected, used and maintained grooming equipment according to workplace and manufacturer instructions
- selected, fitted and correctly use personal protective equipment
- completed post-grooming cleaning and housekeeping procedures
- maintained records for each dog.

### **Knowledge Evidence**

An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:

- dog anatomy, physiology and conformation related to grooming and clipping procedures
- · dog behaviour traits, including signs of distress, illness or restricted movement
- dog coat types and how to determine coat characteristics
- dog grooming products, techniques and services
- industry-recognised grooming and clipping establishment, maintenance and restoration techniques, procedures and equipment for cross breed dog coat types and conditions
- correct use of grooming equipment, including:
  - clippers
  - scissors
  - hand stripping and carding tools
- techniques and strategies for dealing with dogs with special requirements
- lifestyle- and activity-related considerations for clipping of cross breed dogs
- safe and humane dog handling and restraint techniques and procedures
- types and transmission of zoonoses relevant to dogs
- common parasite infections for dogs and methods of prevention and control
- workplace policies, procedures and requirements, including:
  - safety and emergency procedures
  - hygiene and infection control
  - waste disposal
  - animal welfare and humane handling

## **Knowledge Evidence**

- personal protective equipment suitable for activity, including gloves, masks, closed/non-slip shoes, goggles and/or earmuffs
- · safe use of disinfectants and cleaning agents
- cleaning techniques, equipment and materials used in a companion animal workplace
- workplace guidelines and approaches to environmental sustainability including resource use and disposal of waste
- · requirements of workplace record keeping system.

#### **Assessment Conditions**

Assessment of skills must take place under the following conditions:

- physical conditions:
  - skills must be demonstrated in a workplace setting or an environment that accurately represents workplace conditions
- · resources, equipment and materials:
  - live cross breed dogs
  - clippers, scissors and other grooming equipment, including personal protective equipment
  - grooming products
  - PPE suitable for activity
  - · cleaning and sanitising products and equipment
  - · devices used for securing or restraining of dogs.
- relationships
  - clients stipulated in the performance evidence.

Assessors of this unit must satisfy the requirements for assessors in applicable vocational education and training legislation, frameworks and/or standards.
