	All work must be carried out to comply with workplace procedures, according to state/territory health and safety, biosecurity and environmental regulations, legislation and standards that apply to the workplace. Licences or permits may be required for the use of firearms or restricted drugs on crocodiles or if operating vehicles.

## SFICRO4X3 Harvest crocodile eggs from the wild **Knowledge Evidence** An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements, performance criteria and foundation skills of this unit. This includes knowledge of: crocodile egg harvesting techniques, including: marking the uppermost surface of each egg with a soft pencil or other non-toxic indelible mark. while in the nest keeping the eggs horizontal with the marked top surface uppermost as the egg is removed from the nest and placed into the collection crate or box not exposing the eggs to dry conditions or temperatures higher than 34 degrees Celsius packing eggs in material (nest vegetation, vermiculite) that will restrict rolling and maintain humidity maintaining adequate ventilation in the transport container safe crocodile egg transport, including: avoiding injury through rough handling or jolting of eggs and/or containers paying particular attention to avoid mechanical stimulation when eggs are near hatching (between 8 and 16 days) as it may stimulate premature hatching crocodile risk factors in remote waterway environments: estuarine crocodile habitat - any body of water in northern Australia within 100 km off the coast increased risk at night because crocodiles are more active at night increased risk during crocodile breeding season from September to April in Australia aggressive female crocodile behaviour when they are defending their nests and young hatchlings crocodile waterway safety procedures, including: never provoking, harassing or interfering with crocodiles not bringing boats and vehicles within 10 metres of a crocodile never swimming or wading through any water in northern Australian waterways only crossing rivers at shallow water sites or rocky areas in the narrowest section, no more than 30 cm (knee deep) avoiding sites where carcasses are concentrated as crocodiles may have congregated in the area not leaving rubbish or feed scraps around the camp site not preparing food or undertake any activities near the water's edge or adjacent sloping banks wherever possible parking vehicles at least 5 meters from the water's edge and in a clear area

- staying well clear from any crocodile slide marks
- carrying some form of communication equipment
- avoiding working at night
- · being careful when walking through long grass
- zoonotic diseases affecting crocodiles
- safe working practices, including:
  - PPE
  - hygiene and biosecurity procedures
  - basic crocodile manual handling techniques
- crocodile management program or policy aims, including:
  - maintenance a large and healthy population of saltwater crocodiles living in their natural habitat in the Northern Territory
  - promotion of the saltwater crocodile as a natural resource that has economic use and benefit if used sustainably
  - respect for the cultural values of the Indigenous population with regard to crocodile management
  - management of concentrated numbers in areas where there is a high risk to people, livestock and pets
  - provision for crocodile awareness and information in parks, reserves and conservation areas
  - work with other government groups, business and industry to make locals and visitors aware of crocodiles
  - encouragement for everyone to be responsible in activities near the natural environment of saltwater crocodiles
- state and territory legislation or regulation associated with crocodile waterways and crocodile activity.
- biosecurity guidelines for crocodile waterways:
  - not contaminating waterways
  - observing standard operating procedures (SOPs).
