The unit applies to individuals, with prior industry or professional experience working with horses, who are responsible for maintaining the health and welfare of horses within a horse facility. They work autonomously and apply specialist knowledge and skills to provide and communicate solutions for predictable and unpredictable problems.
	Commonwealth and state/territory health and safety, and animal welfare legislation, regulations and codes of practice relevant to interacting with horses apply to workers in this industry. Requirements vary between industry sectors and jurisdictions.
	No occupational licensing or certification requirements apply to this unit at the time of publication.

#### Performance Evidence

An individual demonstrating competency must satisfy all of the elements and performance criteria of this

There must be evidence that the individual has:

- · established and evaluated a horse health strategy for an equine workplace, including:
  - · documented a health care strategy
  - trained and monitored at least two team members in horse health care procedures and compliance with safe work, infection control and biosecurity practices
- implemented and recorded horse health care plans for at least three horses, including for each horse:
  - assessed and recorded indicators of horse health
  - · completed routine, daily checks on at least five occasions
  - · completed a preventative treatment program
- incorporated and implemented recommendations from two different equine health professionals into the health care plan of two of the three horses above.

### Knowledge Evidence

An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:

- · key features of horse anatomy and physiology
- common equine health conditions, diseases and injuries, including signs, causes and treatment
  options
- common preventative health treatments, including parasite treatments and vaccinations
- role and types of services offered by equine health professionals, including:
  - veterinarians
  - farriers and hoof care practitioners
  - · equine dentists
  - body work or massage therapists
  - alternative equine therapies
  - horse educators to address behaviours impacting on health and welfare
- indicators of horse dental age, health and problems
- indicators of hoof problems and basic hoof care techniques, including rasping and shaping the hoof and removing shoes
- key requirements of workplace health and safety requirements relating to:
  - risk assessment and control relating to safe interactions with horses
  - due diligence for safety of team members and other personnel
  - safe, low stress horse handling techniques
  - safe handling and storage of medicines, chemicals and cleaning agents
  - personal protective equipment (PPE)
- key requirements of infection control and biosecurity relevant to horse disease, hygiene, notifiable diseases, and quarantine or isolation procedures
- key requirements of animal welfare legislation and codes of practice relating to safe, humane and ethical care of horses.

## **Assessment Conditions**

Assessment of the skills in this unit of competency must take place under the following conditions:

  - an equine workplace or an environment that accurately represents workplace conditions
- resources, equipment and materials:
  - live performance horses assessed as suitable for the skills and experience of the individual
  - equipment, materials and treatments required for activities specified in the performance evidence
  - · PPE correctly fitted and applicable to activity
