#### **Performance Evidence**

An individual demonstrating competency must satisfy all of the elements and performance criteria of this unit.

There must be evidence that the individual has planned and organised at least one international event or competition, involving fit competition performance horses, including:

- researched and evaluated eligibility and compliance requirements with international performance horse competition and sport rules and regulations
- · completed a cost-benefit analysis of the risks and opportunities of competing internationally
- organised horses, required equipment and tack, accommodation and transportation for the international event
- organised staff travel and accommodation and in-country support personnel
- implemented strategies to minimise horse health and welfare risks associated with international competition and travel
- · organised and complied with import and export quarantine and biosecurity regulations.

# Knowledge Evidence

An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:

- · international performance horse competition disciplines
- countries offering various types of performance horse competition
- international competition ruling bodies in relevant discipline
- personnel involved in organising international competitions, including:
  - · officials, suppliers, veterinarians, allied health professionals
  - · international and in-country transport providers
  - support organisations or individuals located in destination country
- rules and regulations associated with international competitions in relevant discipline, including:
  - rules regarding endorsements
  - qualification or eligibility criteria
- sponsorship or grant funding opportunities offered by commercial, industry bodies, and novel funding sources such as crowd funding via social media
- criteria to determine horse suitability for international competition, including:
  - fitness and condition
  - health
  - vaccination status

  - staffing
  - equipment and tack
  - accommodation for people and horses
  - · transport for people and horses
- · horse transport options, risks and benefits
- health and welfare issues associated with competing overseas and with long-haul transport
- requirements of import and export quarantine and biosecurity regulations for competing horses
- formats for cost-benefit analysis and business plan
- key requirements of current codes of practice and legislative requirements for:
  - health and safety
  - biosecurity
  - animal welfare, including Prevention of Cruelty to Animals legislation.
