<b>Performance Evidence</b>	
<p>An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit.</p> <p>There must be evidence that the individual has developed and applied fertiliser and soil ameliorant product knowledge on at least one occasion and has:</p> <ul style="list-style-type: none"> <li>• identified fertiliser and soil ameliorant products using information about their characteristics</li> <li>• provided information to customers about fertiliser and soil ameliorant products</li> <li>• recognised and reported workplace health and safety hazards and used safe work practices</li> <li>• applied workplace health and safety requirements, including fitted and used personal protective equipment (PPE)</li> <li>• used industry standard terminology.</li> </ul>	
<b>Knowledge Evidence</b>	
<p>An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:</p> <ul style="list-style-type: none"> <li>• characteristics and key label components, including product analysis, impurities and warnings of the range of fertiliser and soil ameliorants sold or handled in the workplace</li> <li>• key environmental, workplace health and safety and food safety risks associated with the use, spreading, storage, handling and transport of fertilisers and soil ameliorants</li> <li>• workplace requirements applicable to health and safety in the workplace for handling, storage and application of fertiliser and soil ameliorants including appropriate use of PPE.</li> </ul>
